MEMORANDUM OF UNDERSTANDING

This Memorandum of Understanding is signed on date 11 December 2021 between **Shri S K Shah and Shrikrishna O M Arts College, Modasa**, and having its office/campus at *C/O Shri M. L. Gandhi Higher Education Society, Modasa College Campus, Modasa Pin- 383315, Dist. Aravalli* through its Authorized signatory **Dr. Dipakbhai H. Joshi, Principal**

and

AVS Adani skill development Center (ASDC), a non-profit organization registered under Section 8 of the companies Act, 2013 and having its office Adani Corporate house, CBD Shantigram, 55 Highway Khodiyar, Dascroi, Ahmedabad, Gujarat, 382421 through its Authorized signatory **Mr. Jatin Trivedi** (hereinafter referred as "ASDC")

(Hereinafter, individually **Shri S K Shah and Shrikrishna O M Arts College, Modasa** and **ASDC** may be referred as a "Party" and collectively as "Parties")

PREAMBLE

Whereas **Shri S K Shah and Shrikrishna O M Arts College, Modasa**, is desirous to enhance the skill development activity near village for youth imparting the Training to local youth

Whereas Adani skill Development Centre (ASDC) With an ideology to make the youth of India "Saksham" brings World Class Skill Development Training for Indian youth and imparts vocational training in the field of various sectors like Beauty, Hospitality, Retail, Apparel etc. and placement programmer for apprentices among the educated young persons of India

Now, THEREFORE, THE PARTIES HERETO HEREBY AGREES AS FOLLOW:

1) Scope of Understanding

"ASDC" is hereby entering into understanding with **Shri S K Shah and Shrikrishna O M Arts College, Modasa** for imparting the skill-based training in the field of the Local youth

2) Term & Appointment

The MOU shall be a period of January'22 - December'24 years during which the **ASDC** shall depute the Trainer and give training in the below trades with fees

- 1) Beauty Therapist. Rs. 6000 per Student

Adani Skill Development Centre will add more trades as per market needs when required.

3) FINANCIAL

Shri S K Shah and Shrikrishna O M Arts College, Modasa will provide necessary space to **ASDC** to operate these trades. **ASDC** will charge mentioned fees from beneficiaries to run its operations



4) **Obligation of Shri S K Shah and Shrikrishna O M Arts College, Modasa**

- a) **Shri S K Shah and Shrikrishna O M Arts College, Modasa** shall provide the appropriate place/venue and infrastructure with electricity to **ASDC** to impart the said Training(s) at Rs. 1 per month.
- b) To provide the place whereby the signage of the **ASDC** and **Shri S K Shah and Shrikrishna O M Arts College, Modasa** jointly can be displayed
- c) To support in mobilization of candidates to undergo Skill Development Training at **Shri S K Shah and Shrikrishna O M Arts College, Modasa** operated by **ASDC**

5) **Obligation of ASDC.**

- a) **ASDC** shall provide the Trainer for the Training
- b) **ASDC** shall provide content, lab equipment and consumables for conducting the training program
- c) The training courses and duration thereof shall likely be as per the modules of the National Skill development Corporation (NSDC)
- d) To provide Certificate on completion of the successful training
- e) To support candidates to get job opportunity

6) **Other Terms**

- a) **ASDC** or any of its Trainers/employees shall not be liable for any incidental, special or consequential damages to the infra/machineries/equipment, or any theft at the premises of the **Shri S K Shah and Shrikrishna O M Arts College, Modasa** arising out of performance under this MOU. And further shall not be liable to **Shri S K Shah and Shrikrishna O M Arts College, Modasa** for any consequential loss or damage or injury to any third party on any account whatsoever or by virtue of its executing or acting under this MOU.
- b) **ASDC** does not warrant nor give any kind of guarantee regarding the success of the Training or generation of any kind of employment
- c) The MOU stands terminated by either of the party at any time upon giving/completion of the training with prior written notice. Upon expiry of the term of this MOU it may be renewed as discussed mutually between the parties
- d) Each party shall retain all right, title and interest, including all copyrights, patent rights, and rights in trademarks, service marks, logos, and commercial symbols. Neither party shall acquire any interest in the other party's intellectual property or any other products, services or materials or any copies or portions thereof, provided by such party pursuant to this MOU and any commercial use of the intellectual property other than specifically agreed pursuant to this MOU, is strictly prohibited
- e) **Public disclosure** - each party shall keep this MOU and its terms confidential and shall make no press release or public disclosure, either written or oral, regarding the transactions contemplated by this MOU without the prior written consent of the other party



- g) This Agreement shall be governed by and in accordance with the laws of India and the courts of Ahmedabad shall have exclusive and sole jurisdiction over any disputes, difference or questions arising out of or in connection with or relation to the terms of this Agreement.





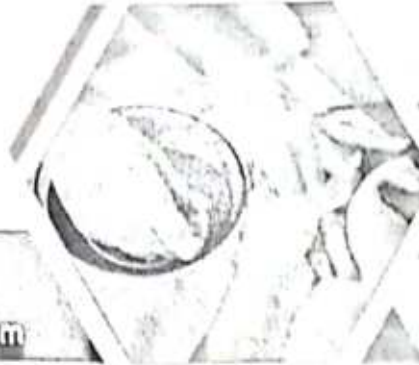
