Preamble

- Activities will focus on promoting attitudinal changes and enhancing the participation of women across all levels of society.

2. Strategic Areas of Partnership

The main areas of cooperation between the College and Stree Chetana include:


- Establishing effective grievance redressal mechanisms and ICCs.
- Providing advisory and consultancy services on grievance handling and ICC operations.
- Collaborating on initiatives to support the Women Development Cell and promote gender equality and women's empowerment.

3. Terms of Collaboration

- The collaboration will commence on the date of signing this MoU and will remain in effect for [insert duration, if applicable].


