Preamble

This Memorandum of Understanding (MoU) is entered into by and between Shri S.K. Shah and Shrikrishna O.M. Arts College, Modasa represented by Dr. Dipak Joshi Principal, and Shishuvihar, represented by Dr. Nanakbhai Bhatt, Secretary, collectively referred to as "the Parties," to establish the terms and conditions for mutual cooperation.

1. Purpose and Objectives

2. Mechanisms to Implement the Agreement



2.4. Upon mutual agreement on the proposed activities, the Parties shall formalize their commitment through joint action plans and allocate necessary resources accordingly.

2.5. The Parties may enter into supplementary agreements or contracts, either with each other or with third parties, to delineate financial obligations, address confidentiality concerns, clarify intellectual property rights arising from the collaboration, and resolve other pertinent matters.

2.6. This MoU serves as an initial framework and does not impose any financial or legal obligations on either Party beyond those explicitly agreed upon herein.

3. Duration and Termination

3.1. This Agreement shall come into effect upon signing and remain valid for a period of [specify duration]. If neither Party intends to terminate this Agreement, written notice must be provided no less than [specify notice period] prior to its expiry to extend the Agreement for a subsequent period.

4. Miscellaneous


4.1. This MoU does not preclude either Party from entering into similar or different agreements with third parties.


