Preamble

This Memorandum of Understanding (MoU) is entered into between Shri S.K. Shah and Shrikrishna O.M. Arts College, Modasa, represented by Dr. Dipak Joshi, Principal, and Smt. Kokilaben A. MSW College, Modasa, represented by Dr. Rakeshbhai Prajapati Principal, collectively referred to as "the Parties," to establish a framework for collaboration and mutual cooperation.


1. Purpose

The purpose of this MoU is to promote cooperation between the two institutions in areas of mutual interest, including to:

academic collaboration, joint research, student exchange, etc.

2. Terms of Agreement

2.1 Scope of Collaboration: The Parties agree to explore and implement collaborative activities that support the objectives outlined in this MoU.

2.2 Implementation Mechanisms: A Joint Committee comprising representatives from both institutions shall be established to oversee the implementation of this MoU. The Committee shall meet to review progress, discuss joint activities, and resolve any issues that may arise.

2.3 Responsibilities: Each Party shall designate responsible individuals to coordinate activities and communication between the institutions.

2.4 Resource Allocation: The Parties shall allocate necessary resources, including but not limited to personnel, facilities, and equipment, as mutually agreed upon for the successful implementation of joint activities.

3. Duration and Termination

3.1 Effective Period: This MoU shall come into effect upon signing and remain valid for a period of five year.

3.2 Renewal and Termination: At the end of the initial period, this MoU may be renewed by mutual written agreement of the Parties. Either Party may terminate this MoU with written notice, citing valid reasons for termination.

3.3 Ongoing Projects: In the event of termination, ongoing projects initiated under this MoU shall be completed in accordance with agreed-upon terms and conditions.

4. Miscellaneous

4.1 Non-exclusivity: This MoU does not preclude either Party from entering into similar agreements with other institutions or organizations.

4.2 Amendments: Any amendments or modifications to this MoU shall be made in writing and signed by authorized representatives of both Parties.

4.3 Dispute Resolution: Any disputes arising out of the interpretation or implementation of this MoU shall be resolved amicably through negotiations between the Parties.


