Preamble

1. Purpose and Objectives

The purpose of this Agreement is to achieve the following objectives:

- To enable the students to know the different methods of teaching.


2. Mechanisms to Implement the Agreement

2.1. Joint Committee: A Joint Committee comprising representatives from both Parties shall be established to oversee the implementation of this MoU. The Committee shall meet [specify frequency] to review progress and plan joint activities.

2.4. Formalizing Commitment: Upon mutual agreement on proposed activities, the Parties shall formalize their commitment through joint action plans and allocate necessary resources accordingly.

2.6. Limitation of Obligations: This MoU serves as an initial framework and does not impose any financial or legal obligations on either Party beyond those explicitly agreed upon herein.

3. Duration and Termination

3.1. Effective Period: This Agreement shall come into effect upon signing and remain valid for a period of five year, If neither Party intends to terminate this Agreement, written notice must be provided no less than [specify notice period] prior to its expiry to extend the Agreement for a subsequent period.
