



MEMORANDUM OF UNDERSTANDING



Between

Dr. Rasiklal Shah Sarvajanik Hospital, Modasa

And

Shri S.K. Shah and Shrikrishna O.M. Arts College, Modasa

This Memorandum of Understanding (MOU) has come in to force from 16-07-2020, between **Dr. Rasiklal Shah Sarvajanik Hospital, Modasa** (hereinafter referred to as "the Hospital") and **Shri S.K. Shah and Shrikrishna O.M. Arts College, Modasa** (hereinafter referred to as "the College").

1. PURPOSE

The purpose of this MOU is to establish a cooperative relationship between the Hospital and the College to promote mutual understanding and enhance collaboration in areas of health, education, and community service.

2. SCOPE OF COLLABORATION

The Hospital and the College agree to work together in the following areas:

- Health awareness and education programs for students and the community.
- Opportunities for students to gain practical experience through internships, volunteer work, and research projects at the Hospital.
- Joint organization of seminars, workshops, and training sessions on health and social issues.
- Exchange of expertise and resources to support the educational and health objectives of both institutions.



3. RESPONSIBILITIES OF THE HOSPITAL

The Hospital agrees to:

- Provide opportunities for students to participate in internships, volunteer programs, and research activities.
- Offer guidance and support from medical professionals for health awareness and education programs.
- Collaborate with the College to organize seminars, workshops, and training sessions.
- Share relevant resources and information to enhance the educational experience of students.

4. RESPONSIBILITIES OF THE COLLEGE

The College agrees to:

- Encourage students to participate in health-related programs and activities organized by the Hospital.
- Facilitate the organization of joint seminars, workshops, and training sessions.
- Provide necessary support and resources for students engaging in internships, volunteer work, and research projects at the Hospital.
- Promote health awareness and education initiatives within the College and the community.

5. DURATION AND TERMINATION

This MOU shall remain in effect for a period of Five years from the date of signing. It may be renewed, amended, or terminated by mutual written agreement of both parties. Either party may terminate this MOU with a written notice of 30 days to the other party.

6. GENERAL PROVISIONS

- This MOU is a statement of intent to foster genuine and mutually beneficial collaboration. It is not intended to create any legally binding obligations between the parties.



- Any disputes arising under this MOU shall be resolved through mutual consultation and negotiation between the parties.
